## **Purpose**

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

#### You are about to purchase a product that is not simple and may be difficult to understand.

#### What is this product?

The product is in the form of a note issued under Cayman law. It is not an interest bearing security. The payment obligations of the product manufacturer are guaranteed by Goldman Sachs International.

#### **Objectives**

The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the class 2694 preference shares issued by GOLDMAN SACHS (CAYMAN) LIMITED (ISIN: GS00PSH26947) (the preference shares). The performance of the preference shares is in turn linked to the performance of the index FTSE 100 Equally Weighted 45 Point Decrement Index (the **underlying asset**). In addition, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The term of the product will end no later than September 6, 2034. However, the product may terminate early depending on the performance of the underlying asset. Each note has a face value of GBP 1. The issue price is 100.00% of the face value. The product will be listed on Luxembourg Stock Exchange (Euro MTF). The subscription period is from July 18, 2024 to August 30, 2024. The issue date is September 6, 2024.

The return of this product is determined by reference to the performance of a modified underlying, which is calculated by reinvesting all gross dividends paid by the underlying component(s) and subtracting a Pre-Defined Decrement. If the actual dividends paid by the underlying component(s) are lower than the Pre-Defined Decrement, the modified performance of the underlying asset will be penalized compared to the traditional "price return" performance. Conversely, if the actual dividends paid by the underlying component(s) are higher than the Pre-Defined Decrement, the modified performance of the underlying asset will be improved compared to the traditional "price return" performance.

**Pre-Defined Decrement:** The Pre-Defined Decrement for the underlying asset is shown in the table below. The Pre-Defined Decrement is expressed per annum and is detached on a daily basis.

**Autocall feature:** If the closing price of the underlying asset on any autocall observation date is at or above the autocall barrier, the preference shares and the notes will terminate on the corresponding autocall payment date. In this case, you will receive an autocall payment for each note that you hold. Autocall observation dates are each trading day rolling annually from August 30, 2027 (inclusive) to August 30, 2033 (inclusive). Autocall payment dates are dates falling 5 business days after each autocall observation date. Autocall barrier for the first autocall observation date is 100.00% of the initial reference price and will subsequently decrease by 5.00% of the initial reference price with each autocall observation date. Autocall payment for the first autocall payment gare by GBP 0.0855 with each autocall payment date.

#### Repayment at maturity:

This section applies only if no autocall occurs as described above.

On September 6, 2034, for each note that you hold:

- 1. If the closing price of the underlying asset on August 30, 2034 is at least equal to 65.00% of the initial reference price, you will receive GBP 1.855; or
- 2. If the closing price of the underlying asset on August 30, 2034 is at least equal to the barrier price, you will receive GBP 1.00; or
- <u>Otherwise</u>, you will receive GBP 1.00 multiplied by (i) the closing price of the underlying asset on August 30, 2034 divided by (ii) the strike price of the underlying asset.

The initial reference price of the underlying asset is the closing price on August 30, 2024.

The strike price is 100.00% of the initial reference price. The barrier price is 50.00% of the initial reference price.


The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

Intended retail investor The product is intended to be offered to retail investors who:

- 1. have advanced knowledge and a comprehensive understanding of the product, its market and its specific risks and rewards, with relevant financial industry experience including either frequent trading or large holdings in products of a similar nature, risk and complexity;
- 2. seek capital growth, expect the movement in the underlying asset to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;
- accept the risk that the issuer or guarantor could fail to pay or perform its obligations under the product but otherwise are able to bear a total loss of their investment;

# What are the risks and what could I get in return?

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a medium-high level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

Inflation erodes the purchasing value of cash over time and this may result in the decline in real terms of any capital reimbursed.

#### Main factors likely to affect future returns on the product

Your return on the product at the end of the recommended holding period will principally be affected by (1) the price at which you purchase the product, (2) the performance of the underlying asset over the recommended holding period and of the exchange rate between the product currency and the underlying asset currency and (3) the ability of the issuer and guarantor to make payments that become due on the product. The value of the product before the maturity date or early termination of the product will also be affected by general economic and market conditions, the volatility of the underlying asset (which is a measure of the extent of movement in the level of the underlying asset), interest rates, the remaining time to maturity and the ability of the issuer and guarantor to make payments.

#### What could affect my return positively?

• An increase in the price of the preference shares that is indirectly linked to an increase in the level of the underlying asset

#### What could affect my return negatively?

- A decrease in the price of the preference shares that is indirectly linked to a decrease in the level of the underlying asset
- The occurrence of a barrier event
- The issuer's and the guarantor's inability to make payments on the product when they fall due

The factors listed above provide general guidance on how changes in the level of the underlying asset may affect your return if you purchase the product at inception and hold it to the end of the recommended holding period. If you purchase or sell the product after inception, your return on the product will also be affected by the purchase or sale price and the level of the underlying asset at the time of sale or, in the case of a purchase, at and following the time of purchase. # What are the costs?

# How long should I hold it and can I take money out early?

Exit costs
